

Water Safety Policy

Rationale

Children are naturally attracted towards water and enjoy playing in and around it, often without understanding the potential danger it presents. According to Kidsafe a child can unfortunately drown in as little as 5cm of water, in less than 20 seconds and the most common factor for childhood drowning is lack of supervision. Alarming statistics show that for every child that drowns, 10 others are rescued from a near drowning incident. A water hazard is defined as: *Anything that can hold 5cm of water and fit a child's nose and mouth*.

Purpose

Staff at Hampstead Preschool want children to engage safely in water play experiences in a range of supervised safe environments, which include Preschool, home environment and community environments such as swimming pools and parks. Water play allows children to engage in activities which promote problem solving skills, language and communication, cooperative play and imaginative play as well as for enjoyment and fun.

How this will be achieved:

Staff will:

- Follow all departmental and WHS practices
- Carry out a detailed risk assessment prior to participating in excursions paying particular attention to potential water hazards
- Identify potential water hazards within the immediate environment and how these will be managed
- Actively supervise children
- Observe play and anticipate behaviour
- Scan and move around the area
- Listen closely for sounds or the absence of noise
- Maintain higher adult/child ratios during riskier activities
- Talk to children about potential hazards
- Eliminate hazards through emptying vessels after use and avoiding the pooling of water
- Provide families with information about water safety around the home
