# **Environmental Sustainability Policy**

#### **Our Vision statement:**

At Renmark Children's Centre we:

Work together with the community, families, children and staff towards a whole centre approach to sustainability resulting in the development of lifelong attitudes and practices.

### Rationale:

Learning about sustainability starts with everyday practice. We believe environmentally sustainable practices should be embedded into the operations of the service.

Our service is committed to protecting our environment to ensure a sustainable future for our children. This involves educators, children and families working together to protect our environment to ensure a sustainable future for our children through continuous improvement we strive to improve every day.

## To support this:

#### Management will:

- Support and actively require sustainable practices be adopted across the site
- Support the use of sustainable materials and resources when developing the site
- Provide a natural play space based on 'Nature Play' principles
- Purchase natural materials and equipment for children to use that foster an understanding of the principles of sustainability
- Promote the use of sustainable environmentally friendly resources e.g. solar panels, auto off taps, dual flush systems, rainwater tanks
- Provide environmental education for educators as part of our professional development program
- Promote the use of electronic communication reducing the need for paper

#### Educators will:

- Implement curriculum that focuses teaching and learning towards environmental sustainability
- Offer the children experiential learning through "hands on" experiences such as working the garden, caring for the animals, recycling scraps, (See Environmental Audit)
- Attempt to recycle % waste, e.g. shredding paper, fruit scraps to animals
- Promote a sense of belonging to the environment locally and globally
- Role model sustainable practices of reusing, recycling and reducing waste

## Children will:

- Be sensitive to the natural environment and take action to preserve and maintain it
- Respect animals as equal inhabitants of our environment, e.g. guinea pigs, snails, frogs and other naturally occurring animals in our centre
- Identify environmental problems and propose innovative solutions
- Use recycling and reusing practices
- Be advocates to their families and model sustainable practices



## Families will:

- Be informed on local and global issues
- Promote a culture of responsibility for the environment
- Support their children using sustainable practices
- Contribute to the centre's policies
- Role model practices to address unsustainable environmental issues
